 This IIM establishes the minimum requirements for projects requiring a wetland compensation plan that is associated with the development and advertisement of a roadway project.

POLICY

- The Environmental Division's Natural Resources Program Manager or the District Environmental Manager, or their designee will provide the designer with project specific information and quantities necessary for the development of a wetland compensation plan.
- Electronic plan files are to be developed in accordance with the 2012 CADD Manual Chapter 6, Section 6.2 and entered into the Falcon Database in accordance with the Electronic Plan Submission Guidelines.
- The plan assemblies for projects requiring mitigation of wetland areas shall include the following information:
 - Existing site conditions (site topography)
 - Site Location Map
 - Survey Data Sheet (Bench Marks, Reference Points, Alignment Data)
 - Typical sections for the mitigation site and access road
 - Detail Sheets (Applicable insertable sheets or special design details)
 - General Notes / Sequence of Construction
 - Summary Sheet (s) (E&S, Grading, Drainage, Incidentals, Planting)
 - Grading Plan
 - Profile Sheet for access road
 - Planting Plan (wetland planting zones and acreage)
 - Cross Sections (mitigation site and access road)
 - Applicable Special Provisions and/or Copied Notes
 - Transport Construction Estimate

SPECIAL PROVISION

 A project specific Special Provision(s) will be provided by the Environmental Division's Natural Resources Program Manager or the District Environmental Manager, or their designee for inclusion in the project contract documents.
