Attached is the Year 2 Progress Report for VDOT's MS-4 Program. The signature of the Commissioner is required on the certification form on page 2 of the report. Information in this report regarding the year two accomplishments for each BMP was provided by the MS4 Steering Committee representative from each responsible Division. L&D reviewed all of the information for consistency and compiled it into one master report.

The MS4 General Permit requires that a Progress Report be submitted to DCR no later than 90 days after the end of each yearly permit cycle. The Year 2 cycle ended June 30, 2010. Because of delays in gathering all of the required information, we were not able to meet that date with a "signed" report. Based on discussions between Roy Mills and DCR staff, he has, today, forwarded a "draft" of this report to DCR with the understanding that the "final" report with the Commissioner's signature will be forwarded to them by October 15.
