The following notes and comments are applicable:

This appendix contains excerpts from the Virginia Department of Transportation (VDOT) Road and Bridge Specifications 2007 (Specifications), which became effective in February 2007. These excerpts are intended to provide a concise reference document of all specifications relevant to VDOT's Stormwater Management, Erosion and Sediment Control, and Virginia Pollutant Discharge Elimination System Permit Programs. These excerpts serve to support and provide the contractual basis for the design, review, and implementation of Erosion and Sediment Control and Stormwater Management Plans, and therefore are included as a component of VDOT's annual submittal of Erosion and Sediment Control and Stormwater Management Specifications to the Department of Conservation and Recreation (DCR).

These Specifications are standard for all contracts awarded by the Commonwealth Transportation Board. The requirements stated herein may be revised or amended from time to time but only to the extent permitted under the special provisions and special provision copied notes included in the specific contract.

Reference (date and title) will be made to these Specifications on plans and contract documents. Revisions to Road and Bridge Specifications

These Specifications are periodically revised and updated thru the use of special provisions and special provision copied notes. While this generally occurs throughout the year, revisions to the specifications related to Erosion and Sediment Control and Stormwater Management are consolidated into two major revision dates: May and November.
